DASRI: An eco-organization for medical waste in self-treatment

Due to their characteristics and the risks they may cause human health and the environment, waste from healthcare activities follow specific routes for the disposal, closely supervised by French law. However, waste generated by households are still regularly mixed with household waste, which exposes the staff and sorting at risk of failure and contamination. To limit these risks, a decree having the effect the establishment of a pathway to Extended Producer Responsibility (EPR) for medical waste sharps produced by patients in self-treatment should be validated by the authorities concerned in the coming months.

The association Dastri created in early February 2012, will be a candidate to become eco-approved organization of the New Network of Waste Activity Infectious clinical (DASRI) produced by patients in self-treatment.

NOTOX specializes in the development of surfboards of new generation high performance and high environmental quality.

Approach and environmental characteristics

Material:

Use of natural fibers and matrix bio-sourced and set up a recycling circuit of the production loss with the manufacturer of technical fabrics flax fiber, resin bio-sourced 55% from the maximum of local resources, national .

Manufacture:

- The manufacturing plant has a strict quality charter guaranteeing the protection of operators.

- Vacuum lamination allowing better impregnation of the fabric, use of less material by reducing 2/3 of the sanding phase.

Logistics:

Using the receive paths for the return of goods waste. Packaging boards from scrap cardboard and reuse.

Use:

User awareness of the right moves daily to compensate for the purchasing of the surfboard. Environmental labeling of products made by HOP3.

End of life:

Establishment of an industry recovery boards in the internal / dismantling stage. Recycling of the PES.

Household Chemical Waste (REP)

As part of the implementation of the commitment of 250 Grenelle Environment, the Order, made under Article R. 543-228 of the Environment Code, establishes the list of chemicals that could pose a risk to health and the environment, and the criteria defining these products according to their nature, their packaging, including the weight or maximum volume of where applicable, content, and, method of use or application of products for sale to households.

This is, in particular, biocides and plant protection appliances, adhesives and sealants, coatings, paints and varnishes, solvents, strippers products surface or unblocking of drains, household acids and alcohols, used fire extinguishers by household and flares boaters.

Directors on the domestic market of these products must contribute to this new line of extended producer Diffuse responsibility for waste Specific household is being set up under Decree No. 2013-12 of January 4, 2012.
